VILLAGE OF JOHNSON CITY WATER DEPARTMENT

The Village of Johnson City updated its quarterly billing format July of 2024

Utility Bills are now sent in a Village of Johnson City Envelope

- If utility bills are not received within the first 10 days of the month, please contact our offices to have an additional copy mailed to you.
- Bill months are January, April, July and October. The Village bills the same months each year.
- Bills are due upon receipt. Payments are due the last business day of each month. 12% will be applied to all unpaid accounts on the following business day.
- POSTMARKED DATES ARE NOT ACCEPTED

A minimum bill will be ran for all accounts with usage 0-1,000 cu ft as long as a meter is installed at the property. An administrative fee of \$50 bill be applied to all unpaid account on the 15th day of the month. A \$150.00 fee will be due in addition to all unpaid balances in the event that a property is shutoff.

Payments can be made in person or mailed to 60 Lester Ave, Johnson City NY 13790.

VILLAGE HALL WINDOW HOURS: 9AM-4PM (DROP BOX AVAILABLE)

Section 270-63 Bills due and payable when rendered; failure to receive bills. All bills are due and payable when rendered. The customer shall be responsible for all bills. Failure to receive a bill shall not excuse payment. No partial payments will be accepted.

Section 270-65 Delinquent bills. In any case any water bill or charges provided for in and by this Part 1 shall not be paid with 30 days following the rendering of the bill, such bill shall be delinquent and shall bear a twelve-percent service charge thereafter.

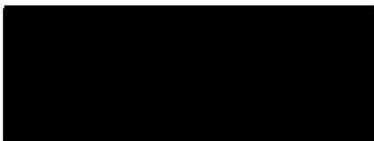

PAYMENT OPTIONS:

Payment can be made in the form of check, bank check or money order. Cash is NOT accepted.
Credit Cards are accepted online ONLY.

In Person:

Payments are accepted at the Village of Johnson City Municipal Office located at 60 Lester Ave, Johnson City NY 13790.
Payments can be made at the window or placed in the drop box located in the lobby.
Business hours are Monday thru Friday, 9:00 am - 4:00 pm, major holidays excluded.

NO PAYMENTS ACCEPTED AT 44 CAMDEN ST.

After Hours Drop Box:

Payments may be placed in the drop box located outside the main doors of the Village of Johnson City Municipal Offices located at 60 Lester Ave, Johnson City NY 13790. Please note that payments placed in the drop box will be processed on the next business day.

U.S. Mail:

Payments may be sent to 60 Lester Ave, Johnson City NY 13790. Please include the remittance stub as it includes all necessary account information. Checks must be made payable to: Village of Johnson City.

POSTMARK DATE NOT ACCEPTED.

Online:

Payments can be made online by visiting www.villageofjc.com. Other online payments portals are not recommended and could result in delay of account payments.

PAYMENT POLICIES:

FAILURE TO RECEIVE YOUR BILL DOES NOT EXEMPT CUSTOMERS FROM LATE CHARGES OR DISCONNECTION.

Quarterly bills are sent out by the first of each billing month and payment is expected by the due date.

Failure to pay by the due date will incur a 12% penalty fee.

Unpaid balances 14 days past the due date will incur a \$50.00 Administration Fee and the property will be posted with a Notice of Nonpayment.

Village Code §270-91 authorizes the Village of Johnson City to shut off your water if you fail to pay this bill. If water is shut off, a service charge of \$150.00 will be incurred and payment of all fees in full is required prior to restoration of services. Please note that if your water is shut off, water service will not be restored until the next business day.

All unpaid utilities remaining on 4/30 each year will be relieved onto the June Village of Johnson City Property taxes.

It is the responsibility of the Account Holder to notify the Village of Johnson City of ANY changes that may be needed to the account.
