Asked why the actual taxes to be levied went down but the percentages went up and stated that he thought that any changes that were made following the public hearing had to be listed. Mayor Deemie stated that there 2 changes that were made, one was that they put money back into one of the stipends and they put \$10,000 into contingency but that was taken out of legal. Mr. King questioned the budget amounts again based on the copy of the budget he had. Mayor Deemie explained that the amount of taxes to be raised is \$10,166,767.00. Mr. King stated that he got an error when he tried to pull up the website on his cell phone and he did tell Diane Salva of the issue and she got them same error when she tried it.

Whereas, the Village Board of Trustees of the Village of Johnson City having, on the 12<sup>th</sup> day of April, 2016 commencing at 7:00pm, duly held a public hearing on the tentative budget filed with the Village Clerk for the fiscal year commencing on June 1, 2016 and having heard all persons desiring to be heard in the matter of the budget for this Village for such fiscal year having been fully discussed and considered, it is Resolved, that the said tentative budget, with such modifications and adjustments as approved by the Board of Trustees, is approved and established as the budget for the Village for the fiscal year beginning June 1, 2016 and that such budget as so adopted be included and attached to the minutes of the proceedings of this Board of Trustees.

Mayor Deemie spoke about how hard the Board worked on the budget this year and explained that they were unable to get under the cap this year. They are approximately \$150,000 - \$200,000 above the cap. The cap was 0.12% this year. In 2015 - 2016 the increase was \$9.45 per \$1,000 with the tax levy increase of 2.52%. This year, 2016 - 2017, the increase is \$8.70 per \$1,000 with a tax levy increase of 2.23%. The borrowing in 2015 - 2016 was \$1.2 million, the borrowing this year is \$670,850.00 (\$300,000 in roads, \$200,000 for a new roof for Village Hall, new software for payroll and accounting, one police car, and curbs and sidewalks). The Mayor explained that when

the first version of the budget came out he was eliminating the 3 SAFER hires in the Fire Department because the grant money is going to run out at the end of May. That would have eliminated \$206,000.00 in salaries and benefits. He further stated that when the SAFER grant was accepted he promised the residents that when the grant money ran out, the Village would not be permanently hiring the firefighters and there was an agreement with the Firefighters Union to that effect. Now, at this time, the rest of the Board has decided to keep them in the budget. This keeps the staff at 29. The Village has applied for another SAFER grant to add 5 more firefighters. Mayor Deemie stated that he tried to do what he had promised the residents.

#### PRIVILEGE OF THE FLOOR - VISITORS

Mayor Deemie opened the second privilege of the floor.

Carol Laskoski, Edward St. – Asked why the Elks are using the Court Room. Mayor Deemie explained that it was for the annual Drug Quiz Show.

Sarah Maxima, Andrews St. (Library Board) – Asked about the grant for the Library that was coming from Assemblywoman Lupardo for the roof. Mayor Deemie stated that the Village has not received it yet.

Richard Wallikas, Deyo Hill Rd. — Asked if there are any new Police being hired with the Pharmacy School coming. Mayor Deemie stated that he has spoken to the Chief and they are adding to the force slowly as best they can and said that the Chief has a great plan which has already been showing positive effects. The school will also have its own security. Mr. Wallikas stated that there has been an increase in violent crime in the Village. Mayor Deemie stated that there have been some incidents recently but the Police Department has done a great job solving the issues and projects like this typically help to reduce crime in the area.

Don Slota, Eldredge Ave. – Asked for an update on the Code Committee. Trustee Balles stated that because of the budget meetings they have not met often but they will be reconvening soon. Mr. Slota asked for an update on the house on Floral Avenue where the 2 children died. Mayor Deemie said he will contact Code Enforcement.

Carol Laskoski, Edward St. – Asked if the house on Floral Avenue where the fire was is purchased and the fire damage repaired, does any grandfathering apply to the new owner. Mayor Deemie stated that the house would have to be brought up to current code.

Broome County Legislator Ron Heebner, Riverside Dr. – Explained that the Elks and Rotary will be providing dictionaries to the 3<sup>rd</sup> & 4<sup>th</sup> graders this year in JC. Stated that he called and spoke to Diane Salva about people putting yard signs in public property, especially in the area around the traffic circle and asked that any public officials, DPW employees, Police, etc., remove any of the signs when they see them. Mayor Deemie stated that if he sees one he does remove it.

Diane Bartlow, David Dr. – She is the President of the Friends of the Library and asked if they could advertise their books sales on the marquee on Harry L. Drive.

Mike Tugwell, Greenridge St. – Asked if they found out what was wrong with the Arch. Mayor Deemie explained that the NYS DOT came and helped us stabilize where it was crumbing. The Village is looking for money to do a more permanent stabilization. It's is about a \$400,000 project to take it apart and put it back together again. He is working with the company that did the estimate to work on looking at the inside of the Arch without taking it apart. Mr. Tugwell stated that he heard a rumor that the carousel is falling apart and won't be running this year. Corinna Johnson said no, it's Carousel Day that is not happening this year. Mayor Deemie stated that there aren't any issues with the carousel itself. He stated that the Highland Park carousel will not be running for part of this year. It has a major roof issue and they need to dismantle the carousel to fix the roof. Mayor Deemie stated that the carousel at Ross Park is also scheduled to be closed this year for renovations. Mr. Tugwell asked if he can bring a microwave to the electronics drop off. Mayor Deemie explained that there was a flyer on the table listing what can be brought to the drop off.

Julie Deemie, Zoa Ave. – Stated that the JC Partners Organization is a 501c3 and can accept donations specifically for the Arch which they can they give to the Village.

Mayor Deemie closed the second privilege of the floor.
