Minutes of a Regular Meeting of the Johnson City Village Board held on Tuesday, January 2, 2018 in the Municipal Building, 243 Main Street, Johnson City

Mayor Deemie called the meeting to order at 7:30pm, led the Pledge of Allegiance and noted the fire exits.

MAYOR'S ANNOUNCEMENTS

- [1] The next regular Village Board Meeting will be Tuesday, January 16, 2018 at 7:30pm with a work session at 5:30pm
- [2] Christmas trees will be collected on January 8th and January 15th, 2018. All ornaments, tinsel and garland must be removed from the trees. <u>Trees should not be left in a plastic bag at the curb</u>. Residents also have the option of delivering their Christmas trees to the designated area in the northern portion of Boland Park, behind the baseball field backstop.

APPROVAL OF BOARD MINUTES

A motion to approve the minutes of December 18, 2017 special meeting was made by Trustee

King and seconded by Trustee Balles. The motion carried with all those present voting in the affirmative.

PUBLIC HEARINGS

[1] Local Law Amending Chapter 208 of the Village Code entitled "Property Maintenance"

Trustee Balles explains the amendment to Section 208.3.1 regarding Junked Vehicles. Code wanted to make changes regarding permits and storage of junked vehicles and selling of vehicles.

Mayor Deemie opened the public hearing.

Julie Deemie, Zoa Ave - is this subject to interpretation? Is it allowed in the yards or not. It is not vague?

Attorney Sacco further explains the changes.

Vehicle storage permit:

Only one extension will be obtained, the vehicle shall be owned by one of the
inhabitants of the property, the vehicle shall not be parked within the required side
or rear setbacks, the vehicle may not be stored in the required setback except if it
is stored in the driveway.

Vehicle sales permit:

 One vehicle may be located on a parcel of land where the seller of the vehicle resides for a period not to exceed 30 days if it is for sale as long as the vehicle is not located on the lawn of the parcel.

No unlicensed, unregistered or inoperative vehicles shall be parked, stored or left in open in the Village except as follows.

We allow an exception, but a very narrow exception.

Carol Laskowski – If you have a car that is licensed, can you park your car on your yard? Can you put a tarp on it?

Mayor Deemie explains:

If it licensed and has plates, it is not considered a junk vehicle, but you are not supposed to park cars on the front lawns.

Mayor Deemie closed the public hearing.

<u>PRIVILEGE OF THE FLOOR – VISITORS</u>

Mayor Deemie opened the first privilege of the floor.

<u>Rick Wallikas</u>, <u>Deyo Hill Road</u> – Is there a plan for revitalizing downtown with regard to the businesses and how they are maintained? It does not look good when you go down Main St. They should dress up the vacant properties. Make it look more presentable. Who reviews the permits? 219 Main Street and 145 Floral Ave. Code is a weakness in the Village A lot of single family homes and they are not getting certificate of occupancy. Code is not checking into it over the phone, not with an inspection. There are more than one family living in some of these one family homes.

Mayor has been working with the business owners (Tom Sheredy) who has artwork in the windows from the Department of Public Art. We are working with them to dress it up. We are working on a grant right now with the Binghamton Fund for some façade work on a lot of these buildings to dress them up and also streetscape work. It is being addressed and looked at. 219 Main Street is in litigation with the County and we are planning on knocking it down.

Mayor Deemie confirms they are working inside at 145 Floral. Trustee Walker states they took the top floor off and put a new roof on.

Mayor Deemie discusses Hookah Heaven:

It's a permitted use in the downtown so it is hard to say no without litigation. We are working on a local law with the health and cultural district we have and the sale and use of tobacco products and limiting that and limiting how it can be sold or used. We are working on this. The Chief is working with the bar and is aware of the issues.

<u>Carol Laskowski</u>, <u>Edwards St</u> –there are cloths hanging in the window, so if they are working in there, they are freezing in there.

The Mayor will talk to code and see what the status is.

<u>Julie Deemie</u>, <u>Pearl Ave</u> —There should be a time restriction on construction. The Floral Ave project has been going on forever. There has to be some assurance that there is a close date.

Mayor – They have to go before the planning and zoning board and they are given a time limit. He believes they have a building permit and does not know if they extended it. He will check with Code. They are only good for a year. If it goes through planning it does have an end date.

Mayor Deemie closed the first privilege of the floor.

Mayor Deemie opened the second privilege of the floor.

<u>Trustee King and Julie Deemie</u> - question the Resolution 2018-12 Right-of-Way attachment which was not attached.

The Mayor explains it is to put a mini cell service on an existing pole so we can have the right-of-way and we can get rental money from them.

<u>Julie Deemie, Zoa Ave</u> - The Floral Avenue property is taking so long to do the construction. If they have a permit from code, they have the right to go in and see the work progressing. The Mayor will talk to legal and see what the legalities are, if you have a building permit whether you can go in. I will check with code and see what the progress is.

The problem on Main Street as we were trying to dress things up, one property owner purchased six properties, dismantled them, and left them. The problem is that Hurricane Sandy came along and he ran into financial issues because of that. To the best of her knowledge he is losing the properties. He has no money and will not be fixing them up.

The Mayor will reach out to him and find out what is going on and what is going on with his buildings. There are quite a few properties that look empty, but they aren't.

<u>Rick Wallikas, Deyo Hill Road</u> – What is going on with the old EJ building (the big white one)?

The Mayor states it is going to be senior housing with commercial space on the bottom floor. There will be an announcement from the County Executive on January 11, 2018 at 1:00 p.m.

19 Avenue B (Old Volunteers of America building) they are turning it into a foundry building, doing canning for craft brewers. We are working to get that into the \$20 million funding.

<u>Julie Deemie</u>, <u>Zoa Ave</u> - Regarding Trustee Walker voting no on Resolution 10.

Trustee Walker doesn't agree with the policy the way it is written; he doesn't agree with the numbers that are there in order to go out to bid should be lower or how it is written. Trustee Walker feels sometimes the department heads have more control over the spending than the Board does.

Mayor Deemie says it is basically the steps you take to purchase items within the Village. The numbers are set by the federal regulations.

The Departments have budgets and as long as they stay within their budget and nothing looks out of line, that is what the budget is for. They know how much they have for those lines. Every two weeks there is a stack of bills and the Board is required to look at bills and sign off that they have looked at them. They submit questions to Cindy and Cindy gets the responses to the Board on Tuesday.

Mayor Deemie closed the second privilege of the floor.

Declarations of conflicts of interest in regards to our positions with the Village.

Mayor Deemie - works for O'Brien & Gere and would abstain from anything that may be a conflict.

Trustee King – Owns his own business but has no contracts or conflicts with any municipality.

Trustee Giblin – works for Hardy Brooks Insurance Agency and would abstain from anything that may be a conflict.

Trustee Walker – works for Ascension Health Care and would abstain from anything that may be a conflict.

Trustee Balles – is retired and have no personal or financial conflicts.
