Discussion: Mayor Deemie explains the Town of Union waived their end of the issue because they had an incorrect address in regards to when they sent the fine out so the person did not receive the notice for mowing so it was an error on the Town of Union's part. We plan on allowing this reimbursement and then we will bill the town for it, so they owe us.

Resolution #2018 – 182

A motion to authorize reimbursement of \$206 to Bibi Teekasingh for overpayment of refuse fees

Resolution #2018 – 184

A motion to approve an ordinance to amend the 2018 BJCJSTP Budget and transfer \$26,200 from Contingency (J8130.55000) and place \$23,200 into Property Insurance (J8130.54300) and the balance of \$3,000 into Printing (J8130.54103) was made by Trustee King and seconded by Trustee Giblin.

Discussion: Trustee King explains in the last two years there are a lot of buildings that have been taken down and they received reimbursement on property insurance premiums. They anticipated more reimbursement of insurance premiums for this current budget and they didn't

get any so they ended up with a shortfall of money to pay the premium. The \$3,000 is for printing of RFPs, they are trying to hire more personnel and they need to place the ads.

Resolution #2018 – 185

A motion to approve an ordinance to amend the 2018 BJCJSTP Budget and transfer \$16,526.77 from Health Insurance Buy-out (J9060.58001C) to Health Insurance - Retirees (J9060.58002C) was made by Trustee King and seconded by Trustee Balles.

Discussion: Trustee King explains they did not have as many people take the buyout for the insurance so they have money in that line since some people took the single family. They had a retirement that they hadn't planned on so that line came up short so they are transferring from one line to another.

PRIVILEGE OF THE FLOOR – VISITORS

Mayor Deemie opened the second privilege of the floor.

Gail, Sergeant St. – Why do the school taxes keep going up? Sergeant St. is the slums. Residents have moved in and they don't work and are on welfare. Also the January taxes were a big jump.

Mayor Deemie explains the Village Board does not have any control over school taxes. The School Board meeting is what you should attend. The January taxes are Town and County.

Marty Meaney, Weymouth Ln. – Why is there a police presence tonight?

Mayor Deemie responds there was a possibility of a certain irate resident that came in during the week and we had to call the police to come in for that meeting and he threatened to come tonight.

Laurleen Crampton, Riverside Drive – Resolution #2018 - 182 – She has been in that house, she has slept overnight in that house and she has been in every room. Does anyone go there and see that it's a one family house and not three? There are three apartments in there. There is the side door, the main door and there is some kind of thing in the basement that could be an apartment.

Mayor Deemie explains that Code determines if it's a one, two or three family. Code is the one that said it is a one family.

Don Slota, Eldredge Ave. – There is a ribbon cutting ceremony on October 22, 2018 at Noon for the apartment complex, Century Sunrise.

Welcome to Harry Lewis, former Mayor

Marty Meaney, former Trustee and running for office
Chief Dodge of Johnson City Police Department

Julie Deemie, President of the Johnson City Partners, Resident of Zoa Ave – The Johnson City Partners was approached by the publishers of My Town Magazine, a new local magazine, by former local people that have moved back to the area because they love the triple cities and they love Johnson City. It is very exciting to have them here supporting the community because this is a really good publication and it is free. There are short stories about local people and events. It is a very upbeat positive publication meant to foster revitalization in our area. They came to the Johnson City Partners to partner an event and want to do something along Main Street to make it more appealing and get families involved. They are proposing along with the JC Partners a window painting project to take place on November 10th from 9:00 am – 1:00pm if it is not raining and November 18th if it is raining. Children throughout Broome County who are registered will be painting windows up to three foot height where they have permission. It will be called Winter Wonderland and we hope to keep it up through the holidays.

October 27th, there will be clean up along Main Street. Grades 7-12 will be creating artwork to hang inside the windows. It will be a competition and there will be prizes given.

November 9th they will be washing windows.

Mayor Deemie confirms this is in conjunction with the business owners.

Laurleen Crampton, Riverside Drive – Good idea, but how come Johnson City looks so bad? Owego has shops and they seem like they thrive. Even Binghamton, they make it look half way decent.

Mayor Deemie responds we are just starting. There are businesses making repairs to their buildings. There is other business interest in the Village. It is going to take time to see the fruits of our labor. We have had one grant for downtown that we have put over \$1,000,000 into Main Street. Most of it went into the interiors because they were so bad. You have to work on the inside first before you can work on the outside. We just got a huge grant from the Greater Binghamton Fund in order to do some of the façades on Main Street, the fronts of buildings. We are working on things, its coming up with the financing that is difficult. Owego is ahead of us because they already had many Main Street grants and Binghamton has taken over ten years to get where they are once the school came. The one school just came and the other school opens in 2020. It's coming, but it takes time and he guarantees that. The governor's office and many state agencies are looking at us, wanting to spend money here because of the school. We just got some great funding to put a rail trail in the middle of the Village, hoping to hook into the other rail trail. It is about ready to get going, but we have been working on things for years. We have a ribbon cutting for Century Sunrise; it has taken him a couple years to get that going. Downtown is starting to come around and businesses are cleaning up. We need the help of the community also.

Mayor Lewis, Mildred Ave – A few pick-ups, the little things mean a lot. Grass cutting around the Village, Village properties, homeowners and around the Southside Fire Station. The biggest thing and so noticeable is to get the sneakers off the wires on Grand Ave.

Marty Meaney, Weymouth Ln. – Speaking with business owners, they feel the Village isn't giving back as far as enforcement, when dogs are defecating in front of businesses, people defecating behind businesses and littering. They are doing their due diligence to keep their properties in good order, but they aren't feeling as if the Village is doing enough to curb those activities.

Mayor responds the CAT Team is enforcing more than ever before. They have done a lot with trespassing, bikes on the sidewalk, and littering to that effect. He understands what he is saying. We have to see the actions happening. We are starting to nail people for things like that. The CAT Team was advertised and flyers were handed out.

Chief Dodge confirms CAT Team is geared for neighborhoods.

Julie Deemie, Zoa Ave – Mayor went to M&T on Main St, passed someone whose dog was defecating on the sidewalk. When he said something to the individual he was belligerent toward him. The Mayor persisted and the man begrudging said to his son, you go pick that up. It is never an easy situation. As far as Main Street businesses, the JC Partners, including her and the Mayor have spent years, digging through the tree boxes picking out feces and needles. But she has never seen a business owner doing that or thanking the JC Partners.

The Mayor adds it should not be on the shoulder of one or two people. It is everyone's Main Street, over 20,000 cars go down Main Street daily.

Don Slota, Eldredge Ave. – Are the buildings behind us being knocked down?

The Mayor replies it is for sale, but I have not heard that it is. As far as I know, no one is in there now. Code has posted it inhabitable.

Mayor Deemie closed the second privilege of the floor.
