PUBLIC HEARINGS

[1] Local Law to Override the Tax Levy Limit Established in General Municipal Law Section 3-C

Mayor Deemie opened the public hearing.

Carol Laskowski, Edward St – Asked for a description.

Mayor Deemie explained it is the tax cap which is based on a formula. We have to have the public hearing and vote on the override, but the override is not needed because we are under the cap.

Mayor Deemie closed the public hearing.

Mayor Deemie opened the public hearing.

Richard Balles, Richard St - Questioned amounts on budget regarding Code Enforcement.

Mayor Deemie, Trustee Giblin and Trustee Meaney responded.

Bruce King – Notes that the police and overtime costs are still in the budget for field days. He suggested having bands in the park with those monies.

Paul Stratton, Lester Ave – Town of Union Code enforcement looks the other way on violations.

Karen Beebe, Port Dickinson – Did a decision get made regarding Floral Park pool?

Mayor Deemie confirmed it is still in the discussion process.

Richard Balles, Richard St – Asked about costs for street sweeper and bucket truck.

Mayor Deemie responded they are for replacing the street sweeper and bucket truck. The street sweeper is in bonding. We are waiting for insurance money for the bucket truck that just caught fire.

Mayor Deemie closed the public hearing.

<u>PRIVILEGE OF THE FLOOR – VISITORS</u>

Mayor Deemie opened the first privilege of the floor.

Paul Stratton, Lester Ave – Pictures of 140 Lester Ave – Wondered why the Village allows someone to keep their building in shambles. Code has been all throughout this building numerous times. It is an ongoing problem and safety is an issue. He wants code brought back to Johnson City.

Mayor Deemie said they are looking into bringing code back to Johnson City.

Julie Deemie, Zoa Ave – Wanted to address a couple of houses on Lester Ave. Is code doing anything? Main Street grant – qualification was show no code violations. According to code, 9-11 showed no open violations so they had to include them on grant.

Corinna Johnson, Cook St – There were violations, but they were not documented.

Jeff Rake, Arthur Ave – Concerned regarding the crime of Johnson City pertaining to the shootings. Is his staff safe? Would like to know if there should be concerns to the general public. Anything about Grand Avenue he should know?

Mayor Deemie responded that it is still being investigated and they can't put out information until the investigation is complete. Mayor Deemie stated they should be safe over there. More news will be coming soon on the second incident.

Chief Dodge stated he interviewed with all major media sources. He feels there is no danger to the general public for those threats at this time. With regard to the second shooting on Grand Ave, they picked up the fourth suspect, they are all locked up on a murder charge and they did recover the weapon. They are still working diligently on the first incident. It is his belief that the victim was specifically targeted so doesn't feel the killer poses a threat to the general public. If there was a threat to the general public, there would be a media blast and they would be going door to door giving people a warning if we thought there was a danger on a specific street.

Harry Lewis, Mildred Ave – For questions regarding code, the Town of Union meeting is tomorrow night and they have the responsibility for code. The Board has nothing to do with the field days and did not make the decision to end field days. The Celebration Committee asked permission to hold the field days at the park. Any field days decisions are made by the Celebration Committee. There are multiple reasons for cancelling; vendors backing out, vandalism, costs, police issues.

Ralph Boone, Whitney Point – Field Days is a family event and thinks the County should do something to help. It is an end of summer function and the Village is taking it away from the kids.

Mayor Deemie explained it is not the Village's decision, it is a Celebration Committee event. It will take a lot of work and effort and a not for profit organization that is willing to run the event. It can be discussed with Harry.

Paul Stratton, Lester Ave – spoke regarding having the people who vandalize clean up their own mess.

Julie Morgan, Binghamton – Has been to the field days since she's been alive. Field Days is a great benefit to the community. She would like to talk to the Committee and discuss field days.

Don Slota, Eldredge Ave –What happened to the study that we were paying \$20,000 for?

Mayor Deemie responded at the last budget meeting it was discussed. We are going to be talking to Dee and the Board about how to proceed.

Julie Deemie, Zoa Ave – Thank you to Harry and the Celebration Committee for all their years of effort and dedication. She did a study and most events life cycle is 6 years so 51 years is amazing. Discussed issues at night, crowd control and overflow of bad things after people leave the field days. Ultimate responsibility to the republic is keeping them safe. She likes Bruce King's idea of bringing music back to the park.

Karen Beebe, Port Dickinson – If the concern is the crowd and what happens after, she doesn't see how a music festival would change that? Closing that doesn't solve that within the community, field days is a symptom of the underlying issues.

Mayor Deemie responded it would not be an all day, all night event. It would be for a couple hours.

Harry Lewis and Mayor Deemie further responded to police issues.

Rick Balles – Is the code study foilable?

Mayor Deemie responded yes, it is foilable.

Mayor Deemie closed the first privilege of the floor.

<u> PRIVILEGE OF THE FLOOR – VISITORS</u>

Mayor Deemie opened the second privilege of the floor.

Don Slota, Eldredge Ave – When is the Floral Park fence getting fixed?

Mayor Deemie responded the money is in the budget. It is still being discussed.

Jeff Rake, Arthur Ave – Was there money put in the budget to bring us up to this century in billing?

Mayor Deemie responded yes, we are trying to figure out the best way to do it and we have multiple systems we are trying to integrate into our accounting software.

Gary Kratochvil, Beverly Pl – His daughter noticed the pagoda at CFJ is nearing completion. Will there be anything for the opening?

Mayor Deemie responded yes, there will be a ribbon cutting and presentation. Donna Lupardo will be there since she got us the money to do the restoration. The goal is to create an information kiosk with display cases containing replica EJ memorabilia for people to see. We are hoping to have a park attendant staff it and it would be open the hours the park is open.

Richard Balles, Richard St – Questioned increase in salary for Planning - Grant Writer/Senior Account Clerk. Is the roof repair for the library a bond?

Mayor Deemie stated there was an amendment to the Administrative Support Unit Contract that increased all admin salaries by \$2500. The Planning and Grant Writer salaries are under the Mayor's Office. Those salaries include ½ of Kim's salary \$15,581 and the \$25,350 for the Zombie Clerk that will be grant funded. Yes, the roof repair is a bond.

Paul Stratton, Lester Ave – Maybe Chief Dodge could shed some input on his building? There are a ton of kids in the building and there are three level three sex offenders.

Chief Dodge responded under the Sex Registry laws there is no specific provision that sex offenders can't be around children. If they are convicted the Judge can make that a condition of their parole or probation, but that doesn't often happen.

Julie Deemie, Zoa Ave – Very pleased with this year's budget. Thanks the Board, Mayor, Cindy and Cheryl for a job well done on the budget.

Trustee Meaney commended the Department Heads for doing a stellar job coming in with realistic budgets and precipitating the creative ways to finance the vehicles as well. A job well done by all parties involved.
