**WHEREAS**, notice of said public hearing was duly advertised in the official newspaper of the Village and posted on the Village Clerk's sign board; and

**WHEREAS**, said public hearing was duly held at Village Hall, 243 Main Street, Johnson City, New York on the 3rd day of December, 2019 at 7:35 p.m. and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said proposed Local Law, or any part thereof; and

**WHEREAS**, pursuant to Part 617 of the implementing regulations of the State Environmental Quality Review Act, it has been determined by the Village Board that this is an Unlisted Action as defined under said regulations. The Village Board has considered the possible environmental impacts of the action, concluded that it will not have a significant adverse impact on the environment, and adopts a negative declaration with respect to the same; and

**WHEREAS**, the Village Board, after due deliberation, finds it in the best interest of the Village to adopt said Local Law.

**NOW, THEREFORE, BE IT RESOLVED** that the Village Board hereby adopts said Local Law as Local Law No. 9-2019 entitled "A LOCAL LAW AMENDING THE VILLAGE ZONING MAP", a copy of which is attached hereto and made a part hereof; and

#### PRIVILEGE OF THE FLOOR – VISITORS

Mayor Deemie opened the second privilege of the floor.

Chris Waters, Adams Ave -

- 1. Has the heat in DPW been done? And how much did it cost?
  - Mayor Deemie responded it is in the process right now. They have put temporary heating in at the moment because it was not functioning at all. Mayor Deemie will have the numbers at the next meeting.
- 2. News on the privatization of the JSTP, do you know when that will happen?
  - Mayor Deemie stated there is nothing new to report at this time and does not know when they will have a decision.
- 3. Floral Park what is going on? Is it still a plan to open the pool next year? If we can't keep Floral Park free of vandalism, how are we going to have a rail trail that miles and miles long? Are we going to close that if there is vandalism?
  - Mayor Deemie responded, it may reopen.
    - o In regards to the graffiti on the slide, the individuals also kicked and broke the safety panels. They are in the process of finding the safety panels which are molded to fit the sides. They are in the process of ordering the panels. Until that is safe, we cannot reopen the park. At this time the bucket truck cannot get in the park because it is too wet.
    - The graffiti is almost off the slide. He is unsure whether they have had time to get back in there and clean it.
    - Yes, the plan is to open a pool.
    - o It is a specific park that has issues. We don't have that issue in the other parks. The rail trail is a whole different animal. Hopefully when the people see the growth and enthusiasm, they will stop vandalizing.

- Trustee Giblin stated that if people are going to continually vandalize the park why are we going to put money into it?
- Trustee Meaney explained we have a fiduciary responsibility to spend the tax payers money wisely. We just spent \$40,000-\$50,000 on a new liner and it gets wrecked. How do we explain to the taxpayers that we are going to spend \$150,000 on a new pool.
- Mayor Deemie stated he chained and locked the CFJ basketball courts in the off season and reopened it when the parks opened. There has been no vandalism to the courts, no garbage and no problems. We are trying to send a message.

*Corinna Johnson, Cook St* – Do you know who is doing the vandalism?

Mayor Deemie responded we knew who broke the chain and lock, but if they are under 18 we cannot do anything.

Mayor Deemie closed the second privilege of the floor.

Mayor Deemie wished Trustee Ben Reynolds a Happy Birthday.
