PUBLIC HEARINGS

[1] Local Law No. 10 - Amending Chapter 200 of the Village Code entitled Plumbing Code

Mayor Deemie opened the public hearing.

Mayor Deemie explained the local law.

We no longer have a plumbing board; we disbanded our plumbing board. We are working with the City of Binghamton and everybody will be taking a standardized test called Prometrics. Binghamton gives the test and they have to take the Prometrics test in Binghamton and they need to show proof they took the Prometrics test in Binghamton and have a current license in Binghamton and then they can get a Johnson City license.

Mayor Deemie closed the public hearing.

[2] Local Law No. 11 - Amending the Village Zoning Map regarding parcels on Riverside Drive and Lusk Street.

Mayor Deemie opened the public hearing.

Linda Espe, Lusk St. – What is going to happen and how is it going to affect her assessment. The guys that do trash and recycling are a great bunch of guys.

Mayor Deemie explained the assessment depends on the assessor. The Town Assessor is Joe Cook. UHS purchased and demolished the properties and they are going to become a parking lot so they don't have to park under the 201 bridge.

Karen McElwee confirmed they will become a parking lot. They will be working with engineering in 2020 to make sure they don't impact the neighbors with regard to storm runoff. It is for the safety of the staff who walked from the parking lot on Grand Avenue.

Tom Poliziano, Arch St. – With UHS taking down the residences, what will be the tax status be, will UHS contribute anything on the parking lots?

Mayor Deemie responded any properties not used for their regular business are taxed. They pay close to \$250,000 in property tax right now.

James Adams, Theron St – He understands you will be working with the neighbors?

Karen McElwee explained they will be working with an engineer to help design proposed parking lot. They will comply with the standards the Village has regarding setbacks, greenspace, vegetation and storm water management and will come before the planning and zoning boards.

Linda Espe, Lusk St. – What is the UHS schedule for the project?

Ms. McElwee responded they do not have a schedule as the blacktop plants are not open in the winter.

Mayor Deemie explained it did go in front of the Planning Board for a recommendation to the Village Board regarding rezoning from urban multi-family dwelling to office overlay zoning district. It had to go to the County for a 239 Review and they came back with no impact countywide in regards to the area. We ran though the SEQRA process and found no impact to the surrounding impact or environment.
