VILLAGE OF JOHNSON CITY A RESOLUTION APPROVING THE PURCHASE OF REAL PROPERTY LOCATED AT 154 ALLEN STREET.

WHEREAS, the real property located at 154 Allen Street, Johnson City, NY, tax map number 143.72-1-29, being approximately 85 x 84 feet of vacant land, is owned by United Health Services (hereinafter the "Premises"); and

WHEREAS, the Village has entered into negotiations with United Health Services, the owners of the Premises, for purchase of property located at 333 Grand Avenue, Johnson City, NY as authorized in September of 2019 in the amount of \$200,000, a copy of such resolution is attached hereto as Exhibit A; and

WHEREAS, United Health Services has offered to include the Premises, 154 Allen Street, a contiguous parcel with 333 Grand Ave in the contract for no additional cost to the Village; and

WHEREAS, the total assessed value of the Premises \$600 the projected Full Market Value of the Premises is \$14,118, according to the Broome County GIS; and

WHEREAS, the Village has a public interest in the Premises; and

NOW THEREFORE, BE IT RESOLVED, that the Mayor of the Village of Johnson City be and hereby is authorized to execute a contract and all necessary legal documents to purchase the aforementioned Premises, together will all improvements, personality, and fixtures, from United Health Services for no additional cost from the purchase authorized in September of 2019; and

Legislative Priorities Public Voice Event Information

Last year's **Legislative Priorities Public Voice Event** was a success and we'd like to bring the public into the budget priorities discussion again this year. As you know, the public has expressed appreciation for your participation in the past and we are hopeful that you will attend again this year.

SUNY Broome will host a "Public Voice" event on Tuesday, February 18th 2020, from 6:30-8:30 pm in Decker 201. We plan to use the same format for this event as we have in the past. We are asking the local NYS legislators to give us their top THREE legislative issues in priority fashion. We are also asking the County Executive and the Broome County Majority and Minority leaders to do the same. Since jobs creation is so important we ask that you not include this issue as it is already the top issue. We will list the issues that each legislator identifies. Using the local print and electronic media as well as contacts through our co-sponsors, we will invite citizens to SUNY Broome Community College on February 6th to identify their top priorities.

The ground rules are as follows:

- Each citizen is encouraged to bring a written list of their top priorities.
- Each citizen will be given up to one minute to identify their NYS Legislative priorities and one minute to identify their Broome County Legislative priorities.
- Elected officials or their designee are invited to attend the event to listen to citizen input but are
 not to talk about any of the issues; likewise citizens, are not to engage legislators/or their
 designees in any conversation during the event about the issues.
- A copy of citizens' views on the legislative agendas for both the local and state bodies will be given to appropriate elected officials.
- If a citizen is unable to attend the event but wishes to contribute input they may mail their issues to Lisa Strahley, Civic Engagement Coordinator, SUNY Broome.

This type of event was pioneered at Panama City Community College and has been heartily endorsed by elected officials. They see citizens coming out to offer their ideas for legislative agenda items as a sort of public opinion poll on what is deemed important.

VILLAGE OF JOHNSON CITY LOCAL LAW NO. 1 FOR THE YEAR 2020

A LOCAL LAW AMENDING CHAPTER 264 OF THE VILLAGE CODE ENTITLED "VEHICLES AND TRAFFIC"

<u>Section 1.</u> Chapter 264 of the Village Code shall hereby be amended as follows:

§ 264-87. Schedule XII: Parking Prohibited at All Times.

A. Add:

Name of Street Side Location

Endwell Street All Third Street to Dead End

[The remainder of this section remains the same]

§ 264-100. Schedule XXV: Red-Line Streets.

Add:

Name of Street

Endwell Street*

[The remainder of this section remains the same]

Section 2. Remainder

Except as hereinabove amended, the remainder of the Code of the Village of Johnson City shall remain in full force and effect.

Section 3. Separability

The provisions of this Local Law are separable and if any provision, clause, sentence, subsection, word or part thereof is held illegal, invalid, unconstitutional, or inapplicable to any person or circumstance, such illegality, invalidity or unconstitutionality, or inapplicability shall not affect or impair any of the remaining provisions, clauses, sentences, subsections, words, or parts of this local law or their application to other persons or circumstances. It is hereby declared to be the legislative intent that this local law would have been adopted if such illegal, invalid, or unconstitutional provision, clause, sentence, subsection, word or part had not been included therein, and as if such person or circumstance, to which the local law or part thereof is held inapplicable, had been specifically exempt therefrom.

Section 4. Effective Date

VILLAGE OF JOHNSON CITY LOCAL LAW NO. 2 FOR THE YEAR 2020

A LOCAL LAW AMENDING CHAPTER 196 OF THE VILLAGE CODE ENTITLED "TRANSIENT RETAIL BUSINESSES AND VENDORS"

<u>Section 1.</u> Section 196-10 of the Village Code entitled "Bond required; imposition of tax; filing of reports; right of entry" shall be repealed and deleted in its entirety and intentionally left blank.

Section 2. Remainder

Except as hereinabove amended, the remainder of the Code of the Village of Johnson City shall remain in full force and effect.

Section 3. Separability

The provisions of this Local Law are separable and if any provision, clause, sentence, subsection, word or part thereof is held illegal, invalid, unconstitutional, or inapplicable to any person or circumstance, such illegality, invalidity or unconstitutionality, or inapplicability shall not affect or impair any of the remaining provisions, clauses, sentences, subsections, words, or parts of this local law or their application to other persons or circumstances. It is hereby declared to be the legislative intent that this local law would have been adopted if such illegal, invalid, or unconstitutional provision, clause, sentence, subsection, word or part had not been included therein, and as if such person or circumstance, to which the local law or part thereof is held inapplicable, had been specifically exempt therefrom.

Section 4. Effective Date

VILLAGE OF JOHNSON CITY LOCAL LAW NO. 3 FOR THE YEAR 2020

A LOCAL LAW AMENDING CHAPTER 300 OF THE VILLAGE CODE ENTITLED "ZONING"

<u>Section 1.</u> Chapter 300 of the Village Code shall be amended as follows:

§ 300-40.9 Home occupations of Board.

- A. Remains the same.
- B. Delete and Replace with: The home occupation shall be carried on wholly within the principal building of an owner occupied one-family dwelling and shall not cover more than fifteen percent (15%) of the floor area.
- C. Remains the same.
- D. Remains the same.
- E. Remains the same.
- F. Remains the same.
- G. Delete and Replace with: The selling of merchandise to walk-in customers and the selling of merchandise not produced by such home occupation is prohibited.
- H. Remains the same.
- I. Remains the same.
- J. Remains the same.
- K. Insert new subsection (K). The new subsection reads as follows: Inventory and supplies shall not occupy more than 50% percent of the area permitted to be used as a home occupation.
- L. Insert new subsection (L). The new subsection reads as follows: The home occupation shall not involve any operation considered to be hazardous.

Section 2. Remainder

Except as hereinabove amended, the remainder of the Code of the Village of Johnson City shall remain in full force and effect.

Section 3. Separability

The provisions of this Local Law are separable and if any provision, clause, sentence, subsection, word or part thereof is held illegal, invalid, unconstitutional, or inapplicable to any person or circumstance, such illegality, invalidity or unconstitutionality, or inapplicability shall not affect or impair any of the remaining provisions, clauses, sentences, subsections, words, or parts of this local law or their application to other persons or circumstances. It is hereby declared to be the legislative intent that this local law would have been adopted if such illegal, invalid, or unconstitutional provision, clause, sentence, subsection, word or part had not been included therein, and as if such person or circumstance, to which the local law or part thereof is held inapplicable, had been specifically exempt therefrom.

Section 4. Effective Date

VILLAGE OF JOHNSON CITY LOCAL LAW NO. 4 FOR THE YEAR 2020

A LOCAL LAW AMENDING THE VILLAGE ZONING MAP

Be it enacted by the Village Board of the Village of Johnson City as follows:

Section 1. The Zoning Map of the Village of Johnson City shall be amended as follows:

The parcel located at 400 Riverside Drive (Tax Map No. 159.32-2-1) shall hereby be rezoned from the Urban Single Family Zoning District and establish it as a Planned Unit Development, and the Village of Johnson City Zoning Map shall be amended accordingly:

[The remainder of the Zoning Map shall remain the same]

Section 2. Remainder

Except as hereinabove amended, the remainder of the Code of the Village of Johnson City shall remain in full force and effect.

Section 3. Separability

The provisions of this Local Law are separable and if any provision, clause, sentence, subsection, word or part thereof is held illegal, invalid, unconstitutional, or inapplicable to any person or circumstance, such illegality, invalidity or unconstitutionality, or inapplicability shall not affect or impair any of the remaining provisions, clauses, sentences, subsections, words, or parts of this local law or their application to other persons or circumstances. It is hereby declared to be the legislative intent that this local law would have been adopted if such illegal, invalid, or unconstitutional provision, clause, sentence, subsection, word or part had not been included therein, and as if such person or circumstance, to which the local law or part thereof is held inapplicable, had been specifically exempt therefrom.

Section 4. Effective Date
