1) BOND RESOLUTION DATED SEPTEMBER 5, 2023.

A RESOLUTION AUTHORIZING THE PURCHASE OF A CHIPPER TRUCK IN AND FOR THE VILLAGE OF JOHNSON CITY, BROOME COUNTY, NEW YORK, AT A MAXIMUM ESTIMATED COST OF \$60,000 AND AUTHORIZING, SUBJECT TO PERMISSIVE REFERENDUM, THE ISSUANCE OF \$60,000 SERIAL BONDS OF SAID VILLAGE TO PAY THE COST THEREOF.

The period of probable usefulness of such object or purpose is 15 years.

2) BOND RESOLUTION DATED SEPTEMBER 5, 2023.

A RESOLUTION AUTHORIZING THE 219 MAIN STREET REVITALIZATION PROJECT IN AND FOR THE VILLAGE OF JOHNSON CITY, BROOME COUNTY, NEW YORK, AT A MAXIMUM ESTIMATED COST OF \$150,000 AND AUTHORIZING, SUBJECT TO PERMISSIVE REFERENDUM, THE ISSUANCE OF \$150,000 SERIAL BONDS OF SAID VILLAGE TO PAY THE COST THEREOF.

The period of probable usefulness of such class of objects or purposes is 50 years.

3) BOND RESOLUTION DATED SEPTEMBER 5, 2023.

A RESOLUTION AUTHORIZING THE RECONSTRUCTION OF WATER MAINS ON PETERSON STREET IN AND FOR THE VILLAGE OF JOHNSON CITY, BROOME COUNTY, NEW YORK, AT A MAXIMUM ESTIMATED COST OF \$500,000 AND AUTHORIZING, SUBJECT TO PERMISSIVE REFERENDUM, THE ISSUANCE OF \$500,000 SERIAL BONDS OF SAID VILLAGE TO PAY THE COST THEREOF.

The period of probable usefulness of such class of objects or purposes is 40 years.

4) BOND RESOLUTION DATED SEPTEMBER 5, 2023.

A RESOLUTION AUTHORIZING THE RECONSTRUCTION OF ROADS THROUGHOUT AND IN AND FOR THE VILLAGE OF JOHNSON CITY, BROOME COUNTY, NEW YORK, AT A MAXIMUM ESTIMATED COST OF \$100,000 AND AUTHORIZING, SUBJECT TO PERMISSIVE REFERENDUM, THE ISSUANCE OF \$100,000 SERIAL BONDS OF SAID VILLAGE TO PAY THE COST THEREOF.

The period of probable usefulness of such class of objects or purposes is 15 years.

5) BOND RESOLUTION DATED SEPTEMBER 5, 2023.

A RESOLUTION AUTHORIZING THE REFURBISHMENT OF SIDEWALKS AND CURBS THROUGHOUT AND IN AND FOR THE VILLAGE OF JOHNSON CITY, BROOME COUNTY, NEW YORK, AT A MAXIMUM ESTIMATED COST OF \$250,000 AND AUTHORIZING, SUBJECT TO PERMISSIVE REFERENDUM, THE ISSUANCE OF \$250,000 SERIAL BONDS OF SAID VILLAGE TO PAY THE COST THEREOF.

The period of probable usefulness of such class of objects or purposes is 10 years.

6) BOND RESOLUTION DATED SEPTEMBER 5, 2023.

A RESOLUTION AUTHORIZING THE PURCHASE OF A TRACTOR IN AND FOR THE VILLAGE OF JOHNSON CITY, BROOME COUNTY, NEW YORK, AT A MAXIMUM ESTIMATED COST OF \$40,000 AND AUTHORIZING, SUBJECT TO PERMISSIVE REFERENDUM, THE ISSUANCE OF \$40,000 SERIAL BONDS OF SAID VILLAGE TO PAY THE COST THEREOF.

The period of probable usefulness of such class of objects or purposes is 15 years.

7) BOND RESOLUTION DATED SEPTEMBER 5, 2023.

A RESOLUTION AUTHORIZING THE PURCHASE OF A PACKER TRUCK IN AND FOR THE VILLAGE OF JOHNSON CITY, BROOME COUNTY, NEW YORK, AT A MAXIMUM ESTIMATED COST OF \$285,000 AND AUTHORIZING, SUBJECT TO PERMISSIVE REFERENDUM, THE ISSUANCE OF \$285,000 SERIAL BONDS OF SAID VILLAGE TO PAY THE COST THEREOF.

The period of probable usefulness of such class of objects or purposes is 15 years.

8) BOND RESOLUTION DATED SEPTEMBER 5, 2023.

A RESOLUTION AUTHORIZING THE PURCHASE OF A WATER VALVE TRUCK IN AND FOR THE VILLAGE OF JOHNSON CITY, BROOME COUNTY, NEW YORK, AT A MAXIMUM ESTIMATED COST OF \$300,000 AND AUTHORIZING, SUBJECT TO PERMISSIVE REFERENDUM, THE ISSUANCE OF \$300,000 SERIAL BONDS OF SAID VILLAGE TO PAY THE COST THEREOF.

The period of probable usefulness of such class of objects or purposes is 15 years.

9) BOND RESOLUTION DATED SEPTEMBER 5, 2023.

A RESOLUTION AUTHORIZING WATER MAIN AND VALVE REPLACEMENT IN AND FOR THE VILLAGE OF JOHNSON CITY, BROOME COUNTY, NEW YORK, AT A MAXIMUM ESTIMATED COST OF \$400,000 AND AUTHORIZING, SUBJECT TO PERMISSIVE REFERENDUM, THE ISSUANCE OF \$400,000 SERIAL BONDS OF SAID VILLAGE TO PAY THE COST THEREOF.

The period of probable usefulness of such class of objects or purposes is 40 years.

Each of such resolutions pledges the full faith and credit of the Village to the payment of the obligations authorized to be issued and delegates to the Village Treasurer, the Chief Fiscal Officer, the power to authorize the issuance of and to sell such obligations. Additionally each of such resolutions contains the estoppel clause provided for by Section 80.00 of the Local Finance Law and authorizes such resolution, after taking effect to be published in summary form in the official newspaper, together with a notice of the Village Clerk, in substantially the form provided in Section 81.00 of the Local Finance Law.
