Sealed bids will be received by the Clerk/Treasurer, 60 Lester Ave, Johnson Village NY 13790, until **10:30 AM**. on Tuesday, **November 19, 2024**. Bids will be publicly opened and read aloud at the **11:00 AM in the Trustee Board room**.

### **INFORMATION FOR BIDDERS**

- 1.** Each bid must be submitted in a sealed envelope clearly marked "ELECTRIC SUPPLY BID" and bear on the outside the name and address of the vendor. If sent by mail, the sealed envelope containing the bid must be enclosed in another envelope labeled as above and is to be sent to the attention of the Clerk/Treasurer.
- 2.** Bids will be publicly opened and read aloud at the 11:00 AM in Trustees Board Room.
- 3.** The Village Trustees, has the right to reject any or all bids if such action is in the best interest of the Village. An irregular or informal bid may also be rejected.
- 4.** In case of default by the contractor, the Village may procure the articles, services or material from other sources and hold the contractor responsible for any excess in cost occasioned thereby.
- 5.** The VILLAGE OF JOHNSON CITY will not be responsible in any manner for verbal answers to any inquiries regarding the meaning of the specifications which may be given prior to the awarding of the contract.
- 6.** Award of this contract will be made to the lowest responsible bidder whose proposal complies with all the provisions required to render it formal and legal and whose record of performance with the Village has been satisfactory.

## **SPECIFICATIONS**

1. REQUIREMENTS: All blank spaces on the bid proposal must be filled out for every location. Proposals which are incomplete, conditional or obscure, or which contain additions not called for, erasures, alterations, ambiguities or irregularities of any kind may be rejected by the Village of Johnson City. All cost components listed below must be listed in the bid price.
2. BID PRICING AND AWARD: Bid pricing is to be in US dollars per megawatt hour. Prices quoted are to include all transportation and additional charges, taxes except Sales Taxes as noted below, and all incremental charges.
3. Term: Service Start Date will be the first available meter read(s) after January 1, 2025 and the term shall run consecutively for the term of the contract.
4. DURATION: Pricing submitted shall remain firm and effective for one (1) day from the date of the bid opening. The Village will work to get a contract in place on the 19<sup>th</sup> with the selected vendor.
5. QUALIFICATION OF BIDDER: The Village shall have the right to take such steps as it deems necessary to determine the ability of the bidder to perform his obligations under the contract, and the bidder shall furnish the Village all such information and data for this purpose as it may request. The right is reserved to reject any bid where an investigation of the available evidence or information does not satisfy the Village that the bidder is qualified to carry out properly the terms of the contract.
6. RESERVATION OF RIGHTS: The contract will be awarded to the lowest responsible bidder complying with the conditions of the Invitation for Bids provided such bid is reasonable and it is to the best interest of the Village of Johnson City. The Village, however, reserves the right to reject any and all bids and to waive any informality in bids received whenever such rejection or waiver is in its interest. The bidder to whom the award is made will be notified at the earliest possible date.
7. SALES TAX: The VILLAGE OF JOHNSON CITY is exempt from paying State or local sales taxes on any material which it purchases. In computing their bids, bidders shall not include the sales compensating use taxes of the State of New York or of any Village and county in the State of New York for any supplies or materials to be used by the contractor for and on behalf of the VILLAGE OF JOHNSON CITY which exempt from such taxes.

**STATEMENT OF NON-COLLUSION**

By submission of this bid, each bidder and each person signing on behalf of any bidder, certifies and in the case of a joint bid, each party thereto certifies as to its own organization, under penalty of perjury, that to the best of knowledge and belief:

- (1) The prices in this bid have been arrived at independently, without collusion, consultation, communication, or agreement, for the purpose of restricting competition, as to any matter relating to such prices with any other or with any competitor;
- (2) Unless otherwise required by law, the prices which have been quoted in this bid have not been knowingly disclosed by the bidder and will not knowingly be disclosed by the bidder prior to opening, directly or indirectly, to any other bidder or to any competitor; and
- (3) No attempt has been made or will be made by the bidder to induce any other person, partnership or corporation to submit or not to submit a bid for the purpose of restricting competition.

The VILLAGE OF JOHNSON CITY reserves the right to reject any bid, request for assignment, renewal or extension for an entity that appears on the Prohibited Entities List prior to the award, assignment, renewal or extension of a contract, and to pursue a responsibility review with respect to any entity that is awarded a contract and appears on the Prohibited Entities list after contract award.
